#### Minutes

### **Old Business**

- Port of Virginia Update: There was no update provided.
- **0 Sixth St., 1603 Seventh Street:** Mr. Donahue reported that the property at 0 Sixth St. and 1603 Seventh Street is in the process of being transferred from the PRHA to the PPIC. Mr. Donahue estimated that the transfer will be completed in the next few weeks.
- **FY26 PPIC Budget Committee:** Mr. Rice and Ms. McSwain were named to serve as the members of the FY26 PPIC Budget Committee.
- PPIC Annual Retreat: The Commissioners determined that the PPIC Annual Retreat will be held on April 22, 2025, immediately following the scheduled regular monthly meeting.
   Discussion for the PPIC Annual Retreat topics will be added to the March meeting agenda.
- City Council/PPIC Joint Meeting July 7, 2025: Mr. Donahue reported that the City Council
  and City Manager have requested a joint meeting to be held with the PPIC. Mr. Steven
  Carter, City Manager, recommended that the PPIC designate its priorities in advance of the
  meeting with City Council to support a productive discussion. Mr. Hugel, City Council Liaison,
  reported that the meeting will be held on July 7, 2025, at 5:30pm to foster collaboration
  with City Council and the City's Boards & Commissions.

### **New Business**

- Mr. Donahue introduced the Economic Development Department's new employee Mr. Leo Akujuobi, Manager of Workforce Development.
- Mr. Hugel reported on the impact that the latest federal employment directives are having on the Norfolk Naval Shipyard. The Shipyard is determining how to handle vacancies caused by the federal government's deferred resignation offer and Department of Defense force reduction measures.
- Mr. Hugel reported that the Norfolk Naval Shipyard has formally executed a separation of the shipyard work from the management of the base itself, resulting in the addition of a commanding officer who will oversee the installation and facilities.
