#### Minutes

- **Port of Virginia Update:** The Port of Virginia update was unable to attend and present due to a scheduling conflict.
- City Council/PPIC Joint Meeting July 7, 2025: Mr. Donahue reviewed action items from the July 7, 2025 joint meeting with City Council, including updates on grant programs, Burton's Point Road development, the 6<sup>th</sup> Street property, and American Cruise Lines Docking Agreement.
- Virginia Port Authority Quarterly Board Meetings: Mr. Foster was confirmed to attend the Virginia Port Authority board meeting on July 29, 2025. The next quarterly meeting is set for October 28, 2025.
- Defense Industry Roundtable Briefing: Tanisha "Sunny" Golston, Business Development Specialist, provided a recap of the June 25, 2025 Defense Industry Roundtable. Topics included workforce training, crime concerns, and regional ship repair challenges.
  Commissioners discussed the importance of legislative support to keep Navy work local and highlighted the opportunities for improving youth engagement in the skilled trades.
