### <u>Financials</u>

Patti Phillips reviewed the September 2022 financial statements, EDA properties available for sale and Statement of Revenues. Ms. Phillips asked the EDA to consider receiving quarterly financial statements rather than monthly statements based on activity. A consensus of the Board of Commissioners supported quarterly financial reporting. ### Old Business

- Mr. Donahue provided an update on the FY22 Business Investment Grant Program. As of September 30<sup>th</sup>, the Real Property Investment Grant program is awaiting completion of three 90-day extensions for completion. The FY22 Smart Start Business Acceleration Grant program will be closing out over the next several weeks.
- Mr. Donahue announced the current round of FY23 Business Investment Grant program opened on October 1<sup>st</sup> and several applications are under review for all three programs. Staff will provide an update at the EDA's November meeting. Mr. Mitchell asked where people are finding out about the grants. Mr. Donahue stated that word of mouth, the Economic Development website and social media have been the primary methods of advertisement.
- Mr. Donahue advised the EDA that 60 Afton Pkwy. and 73 Farragut St. are now undergoing property clean-up and demolition and clearance planning to allow for revitalization and redevelopment. When the related costs are determined they will be presented to the Board.

- Mr. Brown provided a report on the Virginia Institute for Economic Development conference he attended. Mr. Brown shared notable items and interest he took away from event, such as state marketing efforts, tourism opportunities, and business recruitment and retention efforts. Mr. Brown gave insight on the VA250 program in 2026 and suggested the City of Portsmouth should plan to participate. The Board thanked Mr. Brown for the presentation. Mrs. Saunders-Smith asked

Mr. Donahue if there is a regional organization that lobbies the state for economic development funds. Mr. Donahue stated that the Hampton Roads Alliance overseas economic development marketing efforts on behalf of the region. The Virginia Economic Developers Association lobbies for economic development funding at the state level.

 Mr. Smith stated that the Board needs to prepare for an Annual Retreat and asked for topics to be submitted to Vice Chair Mitchell for consideration. Mr. Barber suggested possible partnerships for use of the state's Industrial Revitalization Fund.

### **Report Backs**

- Mr. Donahue spoke about the STARBASE Victory Launching Futures event that was held on October 6 and thanked the EDA for its sponsorship of the event.
- Mr. Donahue updated the Board that Black Brand has provided small business and entrepreneurship reporting information that was requested at its September meeting. The report will be emailed to the Board for review.
- Mr. Donahue informed the Board that the City Council has approved the transfer of property at 2410, 2414, 2416 Turnpike Rd. to the EDA for disposition in support of LBC Transportation, a local trucking company.
