RESOLUTION (3315 High Street) (Development Grant)

WHEREAS, Helping Hands for Heroes Adult Day Center (the "Developer") is engaged in the substantial rehabilitation (the "Rehabilitation") of property having an address of 3315 High Street (Tax Parcel 0300-0010) (the "Property"); and

WHEREAS, the Developer has requested assistance from the EDA in the form of a development grant in the amount of \$30,000 in order to complete the Rehabilitation; and

WHEREAS, Developer has diligently complied with the City's permitting and review process in performing the Rehabilitation, and the completion of the Rehabilitation will benefit the City by: (1) increasing the value of the Property and therefore increasing the City's tax base; (2) improving the High Street corridor; and (3) creating employment opportunities for Portsmouth residents; and

WHEREAS, the provision of a development grant to Developer to complete the Rehabilitation will therefore serve a public purpose;

NOW, THEREFORE, it is hereby RESOLVED that:

- 1. The Board hereby approves a development grant to Developer in the amount of \$30,000.
- 2. The grant shall be made in accordance with a grant agreement to be prepared by staff.
- 3. The Chair and Vice Chair are each authorized to execute the grant agreement.
- 4. The Chair, Vice Chair, and Secretary, and their designees, are each authorized to take such further actions as are necessary or desirable in their sole discretion in furtherance of the purposes of this Resolution.
- 5. This Resolution shall be effective immediately upon its adoption.

Report Backs:

- Mr. Moore stated that a list of speakers will be sent to the board prior to the retreat.
- Mr. Moore said that staff sent all EDA Members the requested links to the maps of the opportunity zones, comprehensive plan, etc.
